Emmanuel AME Church in Charleston, South Carolina, was the scene of brutal murders on Wednesday, June 17, 2015. The thought of murder due to racial hatred is unfathomable and unbearably sad. Nine persons were studying the Word of God when they were gunned down. Talk of pastors needing to be armed in what ought to be places of peace and sanctuary makes me angry. Meeting violence with violence solves nothing.

"Mother Emmanuel" as this church is known sees another tragedy within its walls. It is a church that has been at the forefront of social justice movements. In the 1820s, the church was burned following fears about slave rebellion. In 1834, all Black churches were banned! They opened again and the building was subsequently destroyed by an earthquake and then rebuilt again. "Emmanuel" means "God with us." God is truly with Mother Emmanuel and all of us whose lives have been changed, even in a little way, by this horrific act of murder and hatred. We mourn with the families and friends of those killed and sorrow for a young man who saw no path but violence and hatred. Where have we gone so wrong that for too many violence and killing is the answer? What role do we have to play in creating a society with such skewed values?

Despite the tragedy of this week, this is a church whose roots reach deeply into Charleston and into the South. The deaths will not be forgotten but rather celebrated as Mother Emmanuel survives and lives to tell of resurrection and the message of Jesus Christ once again. Your prayers are asked for all participating in General Convention as at least three major issues are before us:

- (a) Election of a Presiding Bishop.
- (b) Marriage. Not only questions around same-gender marriage but questions around whether the church should act as the agent of the state in signing marriage licenses. There are some who believe the church should not celebrate any marriage. And, as our culture changes, what is marriage and what should it be?
- (c) Re-imagining the church. The Task Force on Re-imagining the Church has much to offer and little of it will be without significant emotional as well as theological reaction.

## The Nominees Who Were Not By The Herald on June 15, 2015

It seems like just yesterday the collective church was unified in an anticipatory buzz as we awaited the slate of nominees for Presiding Bishop. Who will lead us into the future? Who has a vision that will call us back to our mission and energize us for the next triennium?

And then, the slate of candidates came out. We are blessed to have four, highly qualified candidates who have offered their service. They are prayerful servants of the Gospel who will continue to serve Christ's Church well. And yet the conversation throughout the church seems to be as much about who is *not* running, as it is about those who are. There are half a dozen names that people were shocked didn't make the cut. There has been great discussion as to whether or not there "should" have been a woman on the list. A comparison with elections past suggests that fewer bishops wanted to have their names placed in nomination this time around. There were seven candidates in 2006. In 1996 six were originally nominated.


Given these realities, it seems worth stopping to think about whether this job is sustainable, not just for the individual elected to serve, but for us, as the body of Christ. What about our common life as the church has made this position increasingly polarizing?

Part of the issue is endemic to the position itself. Because the Church's polity was constructed at the same time and in the same manner as the United States government, the temptation to equate the Presiding Bishop to the country's President is real. But we must remember that the Presiding Bishop serves as first among equals, serving alongside the bishops who elect her or him after much prayer and consideration of the ways in which the Holy Spirit is moving within the church. Presiding Bishops don't run a campaign that promise to make our lives easier and instantly better. They serve in a theological capacity and a qualitatively different role from that of one in a political office.

The polarization that marks both our politics and our church have not helped one bit. We as a society have come to expect division, and even tolerate unchristian and vicious attacks of character. The digital age has only magnified and accelerated this trend, replacing hastily written

words with face to face conversation. It takes great courage to agree to serve in an age and environment such as this.

At the core of the problem, though, is anxiety: anxiety about the future of the church, about declining numbers and budgets, about division over hot-button issues of the day. Too often the Presiding Bishop has become to focal point of our anxiety and projections. What if we rededicate ourselves to trusting the God who has called us into mission? As opposed to treating our Presiding Bishop as a scapegoat who will take all of our anxieties about life in the church into the wilderness and die with them, might we be so bold as to recommit ourselves to praying for the individual who is called to serve. This is our best assurance that creative, visionary bishops will continue to be willing to serve in this capacity.

recently completed drafting *St. John's Endowment Fund Policies and Guidelines*. We started with a document format supplied by the Episcopal Church Foundation and tailored it to our Parish's specific needs. The final document has been reviewed by the requisite officers of the Diocese of Indianapolis who gave it their hearty approval. The document was then distributed to all vestry members for their review. On June 17, the vestry met and unanimously approved the *Enabling Resolution and the Endowment Committee Policies*. This is a legal document that directs the





Vestry as to how both restricted and unrestricted gifts to the Fund are to be invested and managed and to what purposes the income is to be used. There is also guidance for individuals and/or estate planners to consider when developing a bequest to St. John's. The entire document runs to 12 pages and 4,670 words and will soon be posted on our web site. There will also be additional information about how our endowment income will be used to further St. John's mission in our community.

This is a milestone for St. John's because many small parishes have no specific guidance for their vestries and parishioners about making and managing bequests to the parish. St. John's has modest endowment funds that have accumulated over the years and are currently entrusted to the Diocese for management. We are now in a position to receive and properly manage any size and type of gift and can assure those making bequests that their wishes will be carried out in perpetuity.
